Sibiu, CIF 43966876, email euroclubmioritic@gmail.com, va informeaza ca in incinta spatiului expozitional se efectueaza fotografiile si inregistrari video, prin care pot fi captate imaginile dumneavoastra si ale minorilor pe care ii reprezentati si care va insotesc, fara a se proceda la identificarea persoanelor care apar in fotografiile si inregistrariile video. Scopul prelucrarii datelor personale, constand in imaginile mai sus amintite, este cel de reclama, marketing si publicitate a produselor si serviciilor oferite si a evenimentelor organizate de catre operator, de promovare a miscarii chinologice, precum si de monitorizare a spatiului expozitional in caz de accidente sau incidente. INFORMATION NOTE

Regarding the processing and protection of personal data According to the provisions of the General Regulation on Data Protection no. 679/2016 of the European Parliament and of the Council of the European Union, hereinafter referred to as "GDPR", the Sibiu, str. Strandului, nr 11, jud. Sibiu, CIF 43966876, email euroclubmioritic@gmail.com, informs you that within the exhibition space, photos and video recordings are made, through which you can capture your images and the minors you represent. and who accompany you, without proceeding to identify the persons who appear in the photos and the video recordings. The purpose of the processing of personal data, consisting of the images mentioned above, is that of advertising, marketing and advertising of the products and services offered and of the events organized by the operator, to promote the chinological movement, as well as to monitor the exhibition space in case of accidents. or incidents. The legal basis for the processing of personal data is your consent, explicitly manifested by the action of entering the exhibition space, according to the provisions of Article 6 paragraph 1 letter. A from GDPR. If you do NOT want your images and the minors you represent and accompany you to be processed, please do NOT enter the exhibition space, because your refusal to allow the processing

of images has as a consequence the operator's refusal to allow you access within the exhibition space. On the other hand, your penetration into the exhibition space is an explicit action to agree that the personal data consisting of your images and of the minors you represent and accompany you, will be processed for the purpose stated above. The personal data processed will be disclosed to the general public, for the stated purpose, by publishing / displaying on the website of the operator <http://euroclubmioritic.ro/>. The processing of personal data will be done during the entire period necessary to achieve the above purpose

According to the GDPR, you benefit from:

the right to withdraw your consent at any time, without affecting the legality of the processing carried out on the basis of the consent before its withdrawal
the right of access to the processed data
the right to rectify, delete and portability of data
the right to restrict the processing
the right to oppose processing

You also have the right to address to the supervisory authority the personal data and the courts in any matter related to the processing of the data provided.
